RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to participate in the 2009 Concours on Sunday, June 28, 2009, the undersigned:

1. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT to sue and to release from all liability, the Palo Alto Lions Host Club, the Palo Alto Lions Charities Inc, the Palo Alto Concours Inc, Stanford University, their officers, members, volunteers, and employees as well as all car owners, promoters, sponsors, advertisers or others involved in Concours, collectively RELEASEES; the undersigned makes this agreement on his/her own behalf as well as his personal representatives, heirs and assigns and expressly includes all claims or demands for personal injury, death, property or other damages, arising out of or relating to the Concours.

2. HEREBY AGREES TO INDEMNIFY, DEFEND AND HOLD HARMLESS the RELEASEES: and each of them from loss, liability, damages, attorney's fees or costs they may incur due to the participation of the undersigned in the Concours.

3. HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to negligence of RELEASEES or otherwise while officiating or observing, working or for any purpose involved with or regarding the Concours.

The Concours includes the movement of automobiles on and around the Concours grounds, that it may be dangerous and to that end, the UNDERSIGNED RELEASOR expressly assumes all risks. EACH OF THE UNDERSIGNED expressly acknowledges and agrees that participating in the Concours may be dangerous and may involve a risk of injury and/or death and/or property damage.
